Fundraising

The Krewe has two fundraiser opportunities coming in April and May. In April, there is the Ironman 70.3 at Moody Gardens. The Krewe has been asked to work the bike course again. In May, there is the new women's 5K obstacle event also at Moody Gardens. Both events need a minimum of 30 volunteers; the women's event could use even more people. The Krewe will receive \$250 per ten volunteers at both events. Johnny Lidstone will have sign-up sheets at Thursday meetings, and we hope many members will participate.

Officer and Board Elections

It's election time for the Krewe, and members will be electing officers and board members for the 2013/14 year at the March 28 meeting. A nominating committee has been appointed by the Krewe President, and will take nominations from the floor at the March 14 meeting. A slate of nominations will be prepared that includes incumbents who wish to run for re-election, then the ballot finalized with floor nominations. No nominations will be taken from the floor at the election meeting (3/28). Members wishing to run for a position must be at the meeting to accept the nomination in person to be placed on the ballot. To run for a position, you must be a Krewe member in good standing for 12 months as of nomination night. Voting will be held at the March 28 meeting, and elected officers and board members will take office on April 1 (beginning of the Krewe's fiscal year).
